- d) All renewals of fixed deposit will be at the rates of interest in force at the time of such renewal.
- e) Interim Current Account could be operated only for the purpose of receiving funds to be placed in Forex Plus Fixed Deposit Account and crediting maturity proceeds of the Forex Plus Fixed Deposit Account.
- f) Proceeds of the Forex Plus Fixed Deposit Account will be routed through the Interim current Account when funds in Forex Plus Fixed Deposit Account are remitted outside the country or transferred to another account of the same account holder as specified in the directions issued by the Department of Foreign Exchange Central Bank of Sri Lanka.
- g) No credit facilities would be granted against the deposits placed under this scheme.
