01. To restrict the use of Mobile Banking Facility exclusively to the person/s named overleaf
02. At no time and under no circumstances to disclose to any person the Password/Personal Identity No. [PIN] for use of Mobile Banking Facility. and to treat such as strictly confidential
03. To report to the Bank immediately upon becoming aware that the Password/ PIN has fallen into the hands of any un-authorized party
04. To accept full responsibility for all transactions processed from the use of the Mobile Banking facility.
05. To accept the Bank's record of transactions as conclusive and binding for all purposes.
06. That the Bank has the authority to revoke the account holders right in using Mobile Banking Facility, at any time.
07. That the Bank is not bound to carry out the instructions given by the account holder, if the Bank at its sole discretion believes that such instructions do not emanate from the account holder
08. Not to hold the Bank liable, responsible or accountable in anyway whatsoever for any loss or damage whatsoever arising by any malfunction or failure of the Mobile Banking facility.
09. Notwithstanding to and without prejudice to the generality of provision of (8) above the use of Mobile Banking facility shall be at my/our sole risk and I/We also accept any and all risks, incidental to or arising out of the use of the Mobile Banking facility.
10. To inform the Bank immediately in the event of changing the mobile phone and/ or terminating the mobile connection registered for the Mobile banking facility.
11. That the Bank shall be at liberty to terminate the facility at any time without notice to me/us by canceling the facility
12. Joint account holders are inter-alia jointly and severally bound by these terms and conditions and are jointly and severally liable for all transactions processed by the use of the Mobile Banking facility irrespective of whether the instructions have been given by one or more of the Joint Account Holders
13. All rules and regulations governing the operations on of Current, Savings or any other account shall be applicable to Mobile Banking transactions relating to such accounts
