# **TERMS AND CONDITIONS**

- 1. At all times to regard the Visa Prepaid Travel Card as the property of the Bank and to surrender it unconditionally and without reservation upon demand by the Bank.
- 2. At no time to use or attempt to use the Visa Prepaid Travel Card unless there are sufficient funds in Visa Prepaid Travel Card account to cover the withdrawals, Purchases or any other financial transactions that could be done using the Visa Prepaid Travel Card.
- 3. To restrict use of the Visa Prepaid Travel Card exclusively to myself as it is not transferable.
- 4. Not to use or attempt to use the Visa Prepaid Travel Card after any notification of its cancellation or withdrawal has been given to me by the Bank or by any person acting on behalf of the Bank.
- 5. At no title and under no circumstances to disclose to any Person the Personal Identification. Number (PIN NO) allotted to me to facilitate the use of the Visa Prepaid Travel Card in the Bank's Automated Teller Machine (ATM) or Cash Recycler Machine (CRM) or any other ATM or CRM where the Visa Prepaid Travel Card is accepted.
- 6. To immediately notify the Bank of the loss or theft of the Visa Prepaid Travel Card and to accept full responsibility for all transactions processed from the use of the Visa Prepaid Travel Card except any transactions occurring after the bank shall have confirmed to me that it has received notice of loss or theft of the Visa Prepaid Travel Card and/or of unauthorized acquisition of the Personal Identi¬fication Number.
- 7. Subject to (6) above to accept the Bank's record of fi¬nancial transactions and related fees applicable as conclusive and binding for all purposes and to authorize the Bank to debit my / our account with all amounts debited with or without my knowledge or authority.
- 8. To acknowledge that the amount stated on the ATM or CRM screen or a printed inquiry slip or receipt advice shall not for any purpose whatsoever be taken as conclusive of the state of my Visa Prepaid Travel Card with the Bank.
- 9. Not to hold the Bank liable, responsible or accountable in any way what so ever for any loss or damage howsoever arising caused by any malfunction or failure of the Visa Prepaid Travel Card while using it through ATM / CRM or Pint of Sale Machine, Wallet or using through web for e-commerce transactions.
- 10. Notwithstanding and without prejudice to the generality of the provisions of (9) above the use of the Visa Prepaid Travel Card shall be at my sole risk and I assume any and all risks incidental to or arising out of the use of the Visa Prepaid Travel Card.

- 11. The bank will not be responsible for the Visa Prepaid Travel Card not being honored for any reason whatsoever.
