RULES

- a) There is no obligation on the part of the Bank to release the proceeds of any deposit before its maturity.
- b) The proceeds of the fixed deposit will not be released until the fixed deposit receipt is duly discharged and surrendered to the Bank.
- c) Unless written instructions to the contrary are received by the Bank at least seven days before the maturity of the deposit, the Bank shall have the discretion to renew the deposit for a similar period. Renewal is subject to prevailing guidelines or instructions of Central Bank of Sri Lanka.
- d) All renewals of fixed deposit will be at the rates of interest in force at the time of such renewal.
- e) In the event of the death of the depositor, the proceeds of the deposit and accrued interest if any, shall be payable to the Nominee or shall be distributed among the legal heirs according to the legislation in force.
