And I/We further declare that this Agreement shall not be affected by my death/our or any of our deaths, but shall remain in full force and effect and shall continue to be binding notwithstanding any changes which may from time to time take place by death or otherwise howsoever in the Partners or constitution of my/our firm and or company and that this Agreement does not supersede but is in addition to any Letters of Hypothecation already signed or which may hereafter be signed by me/us in your favour.
