- All primary dealer transactions are subject to the Customer Charter available in the Central Bank of Sri Lanka (CBSL) website [www.cbsl.gov.lk](http://www.cbsl.gov.lk)
- Investor shall agree to abide by the CBSL and Commercial Bank of Ceylon PLC (The Bank) rules and regulations already in force and that shall be enforced in future.
- All transactions on Government Securities shall be dealt by the Bank in accordance with the terms and conditions of the Master Repurchase Agreement (MRA) entered into with the Investor.
- Facilities are made available by the Public Debt Department of the CBSL to receive periodic statements of their Government Securities account in electronic form or through the postal system.
- Investor shall provide all documents and other information required by the Bank/ regulator for the purposes of engaging in Government Securities transactions.
- Bank shall keep information relating to the Investor as confidential. However, the Bank may disclose such information if the Investor consents to or if any such information is required to be disclosed by any statute or by any Court of Law.
- Investor agrees to indemnify the Bank from any loss or liability arising due to carrying out any instruction provided by the Investor.
- Investor agrees to provide instructions pertaining to maturity proceeds at least **seven (07) calendar days** prior to maturity. In the event of such instruction not being received, the Bank may reinvest such proceeds for a period not exceeding the period of the earlier transaction, in accordance with the Customer Charter.
- Investor shall immediately notify the Bank of any changes to existing operating instructions along with required supporting documentation.
- Investor shall pay applicable fees & charges if any published by the Bank from time to time.
- Investor shall inform Primary Dealer Unit of the Bank of any discrepancy on a transaction relating to investments within **14 working days** of such transaction.
